Electricity: Spaces with electricity are limited and will be assigned on a first come, first serve basis and only to those paying the required fees (IN ADVANCE). Your fee covers access to electricity (ONE standard 120v electrical plug with 6 amps). Electrical is suitable for running lights. Additional power requirements are to be provided by vendor. You will be required to provide outdoor extension cords. If you need electricity to cook or to keep food warm, it is highly recommended that you utilize gas or have a generator.
